FSSAI- THE FOOD SAFETY AND STANDARDS (VEGAN FOODS) AMENDMENT REGULATIONS, 2026

Food Safety and Standards Authority of India vide Notification F. No. SS-TOTI(NOTI)/1/2025-Standard-FSSAI. dated 25.05.2026, notifies Food Safety and Standards (Vegan Foods) Amendment Regulations, 2026. The said Regulation introduced a logo that must be embodied on every package of vegan foods after the approval, by substituting sub-regulation (2) of regulation 4, effective from 1st July 2027.

Food Safety and Standards Authority of India vide Notification No. SS-TOFA(NOTI)/3/2024-Standard-FSSAI. dated 27.05.2026, notifies the Food Safety and Standards (Prohibition and Restrictions on sales) Amendment Regulations, 2026. In the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011, in regulation 2.3, in sub-regulation 2.3.14, clause (8) shall be omitted.

MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION- THE LEGAL METROLOGY (PACKAGED COMMODITIES) THIRD AMENDMENT RULES, 2026

The Ministry of Consumer Affairs, Food and Public Distribution, vide Notification G.S.R. 418(E) dated 29.05.2026, has notified the Legal Metrology (Packaged Commodities) Third Amendment Rules, 2026. The amendment permits importers operating through Authorised Economic Operator (AEO) Tier-2 and Tier-3 certified bonded warehouses to make mandatory package declarations at such warehouses, provided all prescribed declarations are affixed before the retail packages leave the bonded warehouse. The amendment also requires companies to disclose the name of the director responsible for violations under the Act, mandates annual updation of registration details through the online portal and provides that registration certificates shall remain valid until cancelled.

MINISTRY OF AGRICULTURE AND FARMER'S WELFARE- ESTABLISHMENT OF NEW CENTRAL INTEGRATED PEST MANAGEMENT CENTRE AT VARANASI, UTTAR PRADESH

The Ministry of Agriculture and Farmer's Welfare vide Notification No. S.O. 2755(E) dated 01.06.2026, notifies the establishment of a new Central Integrated Pest Management Centre at Varanasi, Uttar Pradesh. This office shall work under Directorate of Plant Protection, Quarantine & Storage, Faridabad, an attached office under the administrative control of Department of Agriculture & Farmer's Welfare. The said office will perform activities as per the mandate and objectives of Integrated Pest Management cum Locust Division, Directorate of Plant Protection, Quarantine & Storage.

MINISTRY OF COMMERCE AND INDUSTRY- NOTIFICATION OF IT/ITES SPECIAL ECONOMIC ZONE IN PUDUCHERRY

The Ministry of Commerce and Industry (Department of Commerce), vide Notification S.O. 2776(E) dated 01.06.2026, has notified an area of 8.6230 hectares at Thattanchavady Village, Oulgaret Taluk, Puducherry District, as an Information Technology/Information Technology Enabled Services (IT/ITES) Special Economic Zone (SEZ) to be developed, operated, and maintained by M/s Oulgaret Municipality SEZ under the Special Economic Zones Act, 2005. The notification also constitutes an Approval Committee for the SEZ and designates the SEZ as an Inland Container Depot under the Customs Act, 1962, with effect from 27th May, 2026.

MINISTRY OF COMMERCE AND INDUSTRY- APPLICABILITY OF QUALITY CONTROL ORDERS (QCOS)/BIS REQUIREMENTS ON IMPORTS BY SPECIAL ECONOMIC ZONE (SEZ) UNITS AND DEVELOPERS

Ministry of Commerce and Industry vide Notification No. S.O. 2827(E) dated 03.06.2026, notifies Applicability of Quality Control Orders (QCOs)/BIS requirements on imports by Special Economic Zone (SEZ) Units and Developers and amendments relating to SEZ imports in Para 2.03(A) (iii) of the FTP, 2023, with immediate effect. This amendment is to align the provisions relating to exemption from applicability of Quality Control Orders (QCOs) for imports by SEZ Units and Developers with the provisions of the SEZ Act, 2005 and SEZ Rules, 2006, and to bring clarity regarding the applicability of QCOs.

MINISTRY OF HEALTH AND FAMILY WELFARE- THE DRUGS (FOURTH AMENDMENT) RULES, 2026

Ministry of Health and Family Welfare vide Notification No. 444(E) dated 05.06.2026, notifies the Drugs (Fourth Amendment) Rules, 2026. It amends Drugs Rules, 1945, in Schedule V, in paragraph 2, in the Table, in column (2) relating to unit, for the entry against “Folic acid”, the entry “mcg” shall be substituted.

MINISTRY OF MINES- MINERAL CONSERVATION AND DEVELOPMENT (AMENDMENT) RULES, 2026

The Ministry of Mines, vide Notification G.S.R. 449(E) dated 05.06.2026, has notified the Mineral Conservation and Development (Amendment) Rules, 2026, amending Schedule-I of the Mineral Conservation and Development Rules, 2017. The amendment primarily revises reporting formats and classification requirements for iron ore by introducing two additional hematite ore grades—below 35% Fe and 35% to below 45% Fe—for reporting of Run-of-Mine (ROM) ore, production, dispatch, and related returns. The notification also updates references from Rule 62 of the Mineral Conservation and Development Rules, 1988 to Rule 66 of the Mineral Conservation and Development Rules, 2017 across various prescribed forms, thereby strengthening mineral reporting and monitoring mechanisms.

MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE- DRAFT AMENDMENTS TO ECOMARK CRITERIA FOR ENVIRONMENT-FRIENDLY PRODUCTS UNDER ECOMARK RULES, 2024

The Ministry of Environment, Forest and Climate Change, vide Draft Notification No. G.S.R. 452(E) dated 08.06.2026, has proposed amendments to the First Schedule of the Ecomark Rules, 2024 by revising the environmental criteria for grant of the Ecomark label to six product categories, namely paints and coatings, batteries, paper products, wood substitutes, fire extinguishers, and coir products. The draft introduces stricter sustainability, pollution control, recycled content, resource efficiency, hazardous substance restrictions, EPR compliance, renewable energy usage, QR-code based disclosure requirements, and ISO 14001 environmental management standards.

Ministry Of Agriculture and Farmers Welfare vide Notification No. G.S.R. 453(E) dated 09.06.2026, notified the draft Insecticides (Amendment) Rules, 2026. In the Insecticides Rules, 1971, in rule 19, in sub-rule (1), clause (i) (a), shall be substituted with new clause, for Note II of clause (i), shall be substituted with new clause, and clause (ii) shall also be substituted for new clause and an Explanation shall be added after sub-rule 3.

MINISTRY OF ROAD TRANSPORT AND HIGHWAYS- CENTRAL MOTOR VEHICLES (NINTH AMENDMENT) RULES, 2026

The Ministry of Road Transport and Highways vide Notification No. G.S.R. 458(E) dated 09.06.2026, has notified the Central Motor Vehicles (Ninth Amendment) Rules, 2026, amending Rule 126 of the Central Motor Vehicles Rules, 1989. The amendment streamlines testing, type approval, and certification requirements for altered, retrofitted, adapted, and imported vehicles, recognizes compliance with specified international standards, mandates E20 fuel compatibility requirements for certain imported gasoline vehicles, and updates certification procedures for agricultural tractors and truck body prototypes. The changes aim to simplify regulatory compliance while maintaining vehicle safety and emission standards.

CENTRAL DRUGS STANDARD CONTROL ORGANISATION- SUBMISSION OF COMPLIANCE FOR IMPORTED/MANUFACTURED HAIR COLOUR COSMETICS PRODUCTS AS PER COSMETICS RULES, 2020 AND APPLICABLE BIS STANDARDS

Central Drugs Standard Control Organisation vide Circular dated 10.06.2026, issued that all the importers/manufacturers are required to ensure compliance with the standards under the Cosmetics Rules, 2020 and applicable BIS Standards. Changes/revisions to the label, product composition and product quality specifications shall be reported to the Central/State Licensing Authority as the case may be under the provisions of Rule 15 (2) and Rule 26 (k) of the Cosmetics Rules, 2020.

MINISTRY OF COMMERCE AND INDUSTRY – DRAFT GAS CYLINDERS (THIRD AMENDMENT) RULES, 2026

The Ministry of Commerce and Industry vide Notification No. G.S.R. 461(E) dated 10.06.2026, has issued the Draft Gas Cylinders (Third Amendment) Rules, 2026, proposing amendments to the Gas Cylinders Rules, 2016 by introducing comprehensive safety and operational requirements for CNG Mobile Refuelling Units (MRUs). The draft rules prescribe conditions relating to ownership, approval, emergency shutdown systems, safety distances, refuelling operations, training requirements, equipment specifications, emergency preparedness, record maintenance, and accident reporting. The proposed framework aims to facilitate safe dispensing of CNG to approved vehicles, railway locomotives, vessels, and certain heavy equipment while ensuring strict compliance with safety standards and regulatory oversight.

MINISTRY OF PETROLEUM AND NATURAL GAS- THE NATURAL GAS AND PETROLEUM PRODUCTS DISTRIBUTION (THROUGH LAYING, BUILDING, OPERATION AND EXPANSION OF PIPELINES AND OTHER FACILITIES) SECOND AMENDMENT ORDER, 2026

The Ministry of Petroleum and Natural Gas vide Notification No. S.O. 3001(E) dated 11.06.26 has notified the Natural Gas and Petroleum Products Distribution (Through Laying, Building, Operation and Expansion of Pipelines and Other Facilities) Second Amendment Order, 2026, effective from 10.06.2026. The amendment relaxes the requirement for individual communication before discontinuation of LPG supply by City Gas Distribution (CGD) entities, provided records are maintained showing that notice has already been served through prescribed alternative modes such as notices under the principal order, communications to Resident Welfare Associations or housing societies, hand-delivered notices, posters, flyers, pamphlets, text messages, telephone calls, or recorded voice messages.

MINISTRY OF PETROLEUM AND NATURAL GAS - MOTOR SPIRIT AND HIGH SPEED DIESEL (TEMPORARY REGULATION OF SUPPLY THROUGH RETAIL OUTLETS) ORDER, 2026

The Ministry of Petroleum and Natural Gas vide Notification No. G.S.R. 474(E) dated 11.06.2026, has notified the Motor Spirit and High Speed Diesel (Temporary Regulation of Supply through Retail Outlets) Order, 2026 to ensure the uninterrupted availability and equitable distribution of petrol (MS) and diesel (HSD) amid concerns over supply disruptions, hoarding, and diversion of fuel. The Order empowers the Government to impose temporary restrictions on fuel procurement through retail outlets, including prohibiting institutional, industrial, and commercial consumers from purchasing fuel from retail outlets and limiting diesel sales to a maximum of 200 litres per customer/vehicle per day through vehicle tanks or PESO-approved containers. The measures are intended to safeguard fuel supplies for genuine retail consumers, prevent black marketing and stockpiling, and maintain essential services during extraordinary circumstances. Orders issued under these provisions will generally remain valid for up to 90 days unless revoked or extended.

MINISTRY OF AGRICULTURE AND FARMERS WELFARE – AADHAAR AUTHENTICATION FOR AGRICULTURAL RESEARCH & EDUCATION EXAMINATIONS

The Ministry of Agriculture and Farmers Welfare, through Notification No. G.S.R. 475(E) dated 12.06.2026, has authorized the use of Aadhaar authentication for candidates appearing in examinations conducted by the Department and for examination functionaries involved in the examination process. The notification aims to promote good governance, transparency, efficiency, and the use of digital platforms while ensuring voluntary Aadhaar authentication. The Department may use Yes/No and e-KYC authentication facilities during various stages of examinations and at the time of joining. Importantly, individuals who choose not to undergo Aadhaar authentication or are unable to do so cannot be denied services and may establish their identity through alternative documents such as Voter ID, PAN Card, Driving Licence, Passport, or other government issued IDs.

CAQM- CAQM REVIEWS AIR POLLUTION CONTROL MEASURES IN DELHI-NCR

Commission for Air Quality Management vide Press Release dated 13.06.2026, reviewed the implementation of air pollution control measures across Delhi-NCR, focusing on vehicular emissions, a road dust, construction waste, stubble burning, industrial emissions, and waste management. The Commission stressed strict enforcement of its directions, enhanced monitoring, timely compliance, and targeted actions by State Governments and agencies, which reaffirmed their commitment to improving air quality in the region.

Ministry of Health and Family Welfare, vide Notification No. G.S.R. 477(E) dated 15.06.2026, notifies the Drugs (Fifth Amendment) Rules, 2026. In the Drugs Rules, 1945, in Schedule K, in the column, under the heading Class of Drugs, against serial number 13, in item number (7), the word “Syrups,” shall be omitted.

MINISTRY OF ROAD TRANSPORT AND HIGHWAYS - DRAFT MOTOR VEHICLES (REGISTRATION AND FUNCTIONS OF VEHICLE SCRAPPING FACILITY) AMENDMENT RULES, 2026

The Ministry of Road Transport and Highways vide Notification No. G.S.R.490(E) dated 17.06.26, has notified the Draft Motor Vehicles (Registration and Functions of Vehicle Scrapping Facility) Amendment Rules, 2026 to strengthen the regulatory framework for Registered Vehicle Scrapping Facilities (RVSFs). The draft amendments introduce revised definitions for End-of-Life Vehicles, mandate the use of the centralized Vscrap portal, require a valid Vehicle Scrapping Certificate for cancellation of vehicle registration in most cases, and prescribe detailed equipment, infrastructure, environmental, and safety requirements for scrapping facilities. The proposal also introduces mandatory audits, compliance reporting, and enforcement provisions, including suspension or cancellation of registration for non-compliance, with existing facilities required to meet the new equipment standards within one year of notification.

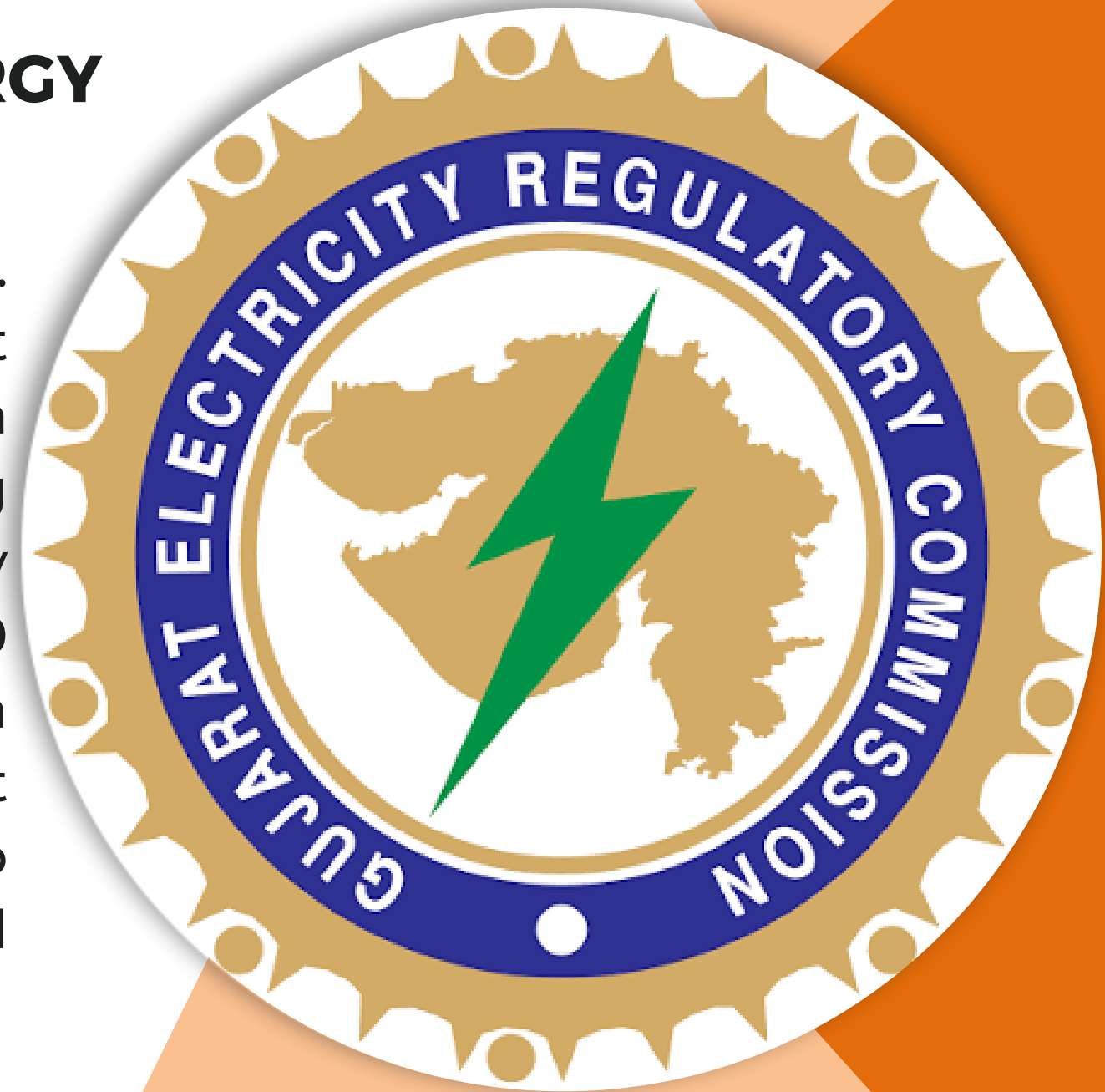

The draft proposes a banking charge of ₹1.00 per unit from 1 September 2026 to 31 March 2027 and introduces a methodology for annual determination of charges based on market conditions, energy banking costs, and distribution licensee data. It also mandates timely data submission by distribution licensees and provides for common banking charges and charge limits.

ANDHRA PRADESH- ANDHRA PRADESH MINOR MINERAL CONCESSION RULES, 1966

Government of Andhra Pradesh vide Notification No. G.O.Ms.No. 126 dated 23.06.2026, notifies amendments to Andhra Pradesh Minor Mineral Concession Rules, 1966 to introduce a preferential allotment framework for quarry leases in favour of registered Vaddera Cooperative Societies. The amendment provides for earmarking up to 33% of the allottable quarry area for eligible societies under a First Come First Served (FCFS) mechanism, subject to a maximum limit of 12 hectares per society. It also prescribes a structured application, scrutiny, and priority determination process, along with a 50% concession on seigniorage fees for eligible societies during the lease period.

DELHI- ANNUAL WINTER AIR POLLUTION CONTROL DIRECTIONS EFFECTIVE FROM 1ST NOVEMBER TO 28TH FEBRUARY EVERY YEAR

The Government of the National Capital Territory of Delhi vide Notification F. No. 10(39)/ENV/2021 dated 23.06.2026, has issued consolidated annual directions to curb air pollution during the winter season (1 November to 28 February). The notification mandates fuel dispensing only to vehicles with a valid Pollution Under Control Certificate (PUCC), restricts entry of non-BS-VI vehicles registered outside Delhi, doubles parking charges, requires staggered office timings with 50% work-from-home in government and private offices, imposes restrictions on construction and demolition activities, mandates installation of anti-smog guns or mist systems for specified buildings and construction sites, prohibits open burning, and prescribes penalties, including environmental compensation and prosecution, for non-compliance.

KERALA- DISTANCE CRITERIA APPLICABLE FOR FURNITURE AND CARPENTRY UNITS WITH MACHINERY SIMILAR TO THAT IN PLYWOOD MANUFACTURING UNITS

Kerala State Pollution Control Board issued Circular No. KSPCB/926/2026-SEE-1 dated 24.06.2026, stating that units under the sectors “Modular wooden furniture” and “Carpentry & wooden furniture”, while processing consent applications, the distance criteria and control measures applicable to such units shall be complied.

RAJASTHAN- RSPCB RESTRICTS FRESH CTE AND CTO FOR HAZARDOUS INDUSTRIES ALONG RIVERBANKS IN PALI, BALOTRA AND JODHPUR

The Rajasthan State Pollution Control Board (RSPCB), vide Order No. F.05 (Gen-106)/RPCB/Textile/874-878 dated 24.06.2026, in compliance with the Supreme Court's directions in the Jojari River matter, has ordered that no fresh Consent to Establish or Consent to Operate shall be granted to hazardous or obnoxious industries along the riverbanks in the districts of Pali, Balotra, and Jodhpur unless the prescribed minimum distance from the high flood line and mandatory river buffer zones is certified by the district-level Water Resources Department. The order aims to ensure strict adherence to environmental safeguards and prevent industrial pollution of river ecosystems.

RAJASTHAN- THE RAJASTHAN MINOR MINERAL CONCESSION (AMENDMENT) RULES, 2026

The Government of Rajasthan, vide Notification No. G.S.R.20 dated 25.06.2026, has notified the Rajasthan Minor Mineral Concession (Amendment) Rules, 2026. The amendments replace references to the State Directorate of Revenue Intelligence (SDRI) with officers of the Directorate of Revenue Intelligence and Economic Offences not below the rank of Deputy Director and Revenue Intelligence Officer in various provisions, thereby expanding the authority of designated enforcement officers for regulating minor mineral concessions.
