MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE- 130TH MEETING OF CAQM'S ENFORCEMENT TASK FORCE (ETF) REVIEWS INTENSIFIED ENFORCEMENT ACTIONS, INSPECTIONS AND COMPLIANCE STATUS ACROSS DELHI-NCR

Ministry of Environment, Forest and Climate change vide Press Release dated 05.05.2026 informed that 130th Meeting of CAQM's Enforcement Task Force (ETF) reviewed Intensified Enforcement Actions, Inspections and Compliance Status across Delhi-NCR. The Commission reiterated the need for robust enforcement, improved data integrity, strengthened inter agency coordination and strict adherence to prescribed environmental norms to ensure effective abatement of air pollution across NCR. Continued focus was laid on enhancing inspection efficiency, ensuring accountability at all levels and expediting enforcement actions.

FSSAI- IMPLEMENTING THE PROCESS FOR PRIOR APPROVAL AND RISK ASSESSMENT THROUGH THE SINGLE WINDOW SYSTEM (EPAAS)

Food Safety and Standards Authority of India vide Office Order dated 06.05.2026, specified that ePAAS shall serve as a unified digital interface for the submission, processing, monitoring, and appeal/review of all applications related to the prior approval and risk assessment of products, ingredients, and claims, as applicable under relevant regulations. And from 1st June, 2026, all applications seeking prior approval or authorization from the FSSAI shall be submitted only through the ePAAS portal (<https://epaas.fssai.gov.in/login>). Necessary guidelines, forms, and formats will be available on the same portal. No manual, offline, or email-based applications shall be entertained thereafter.

FSSAI- FSSAI WEST REGION SEIZES MISBRANDED 'ALKALINE WATER' FOR USE OF NON-PERMITTED INGREDIENTS AND LABELLING VIOLATIONS

Food Safety and Standards Authority of India vide Press Release dated 07.05.2026, released that the Western Regional Office of the Food Safety and Standards Authority of India West Region has initiated significant enforcement action against a manufacturer of Alkaline Water, following a consumer complaint registered through the Food Safety Connect portal. Laboratory analysis confirmed the presence of fulvic acid, a substance not permitted under current FSSAI regulations. Investigations established that this ingredient originated from the addition of black mineral substances and was not inherent to the raw or processed water, confirming a clear violation of established safety standards. FSSAI reiterates its steadfast commitment to ensuring that all food products available to the public are safe, wholesome, and accurately labelled.

CENTRAL POLLUTION CONTROL BOARD- PCB REVISES RECOGNITION OF ENVIRONMENTAL LABORATORIES AND ADDS NEW ACCREDITED LABS

The Central Pollution Control Board vide Notification No. LB/4/2021-INST-Lab-HO-CPCB-HO dated 11.05.2026, has amended its earlier notification relating to the recognition of environmental laboratories under the Environment (Protection) Act, 1986. The amendment revises the recognition details, validity periods, and approved testing parameters for several existing environmental laboratories and government analysts across various States. Additionally, two new laboratories have been included in the approved list. The recognized laboratories are authorized to undertake testing relating to water and wastewater, hazardous waste, soil, air emissions, microbiological and toxicological analysis, among others, for the validity period specified in the notification.

MINISTRY OF ROAD TRANSPORT AND HIGHWAYS- THE CENTRAL MOTOR VEHICLES (SEVENTH AMENDMENT) RULES, 2026

The Ministry of Road Transport and Highways, vide Notification No. G.S.R. 364(E) dated 14.05.2026, has notified the Central Motor Vehicles (Seventh Amendment) Rules, 2026, amending Rule 93 of the Central Motor Vehicles Rules, 1989. The amendment permits Category N2 and N3 motor vehicles, as well as truck trailers, tractor trailers, and semi-trailers transporting white goods or photovoltaic solar panels/modules stacked in multiple layers, to have an overall vehicle height of up to 4.50 metres.

CENTRAL DRUGS STANDARD CONTROL ORGANISATION- CDSCO ISSUES ADVISORY ON PROHIBITED INGREDIENTS AND MISLEADING CLAIMS IN COSMETICS

The Central Drugs Standard Control Organisation, under the Directorate General of Health Services, has issued Public Notice dated 18.05.2026, an advisory cautioning stakeholders against the use of prohibited ingredients, misleading claims, and improper application of cosmetics in violation of the Drugs and Cosmetics Act, 1940 and Cosmetics Rules, 2020. The advisory clarifies that cosmetics are intended only for cleansing, beautifying, promoting attractiveness, or altering appearance and cannot be administered through injections or used for treatment purposes. It further emphasizes that cosmetic labels must not contain false or misleading claims and encourages the public to report violations related to prohibited ingredients or misuse of cosmetics to the concerned regulatory authorities.

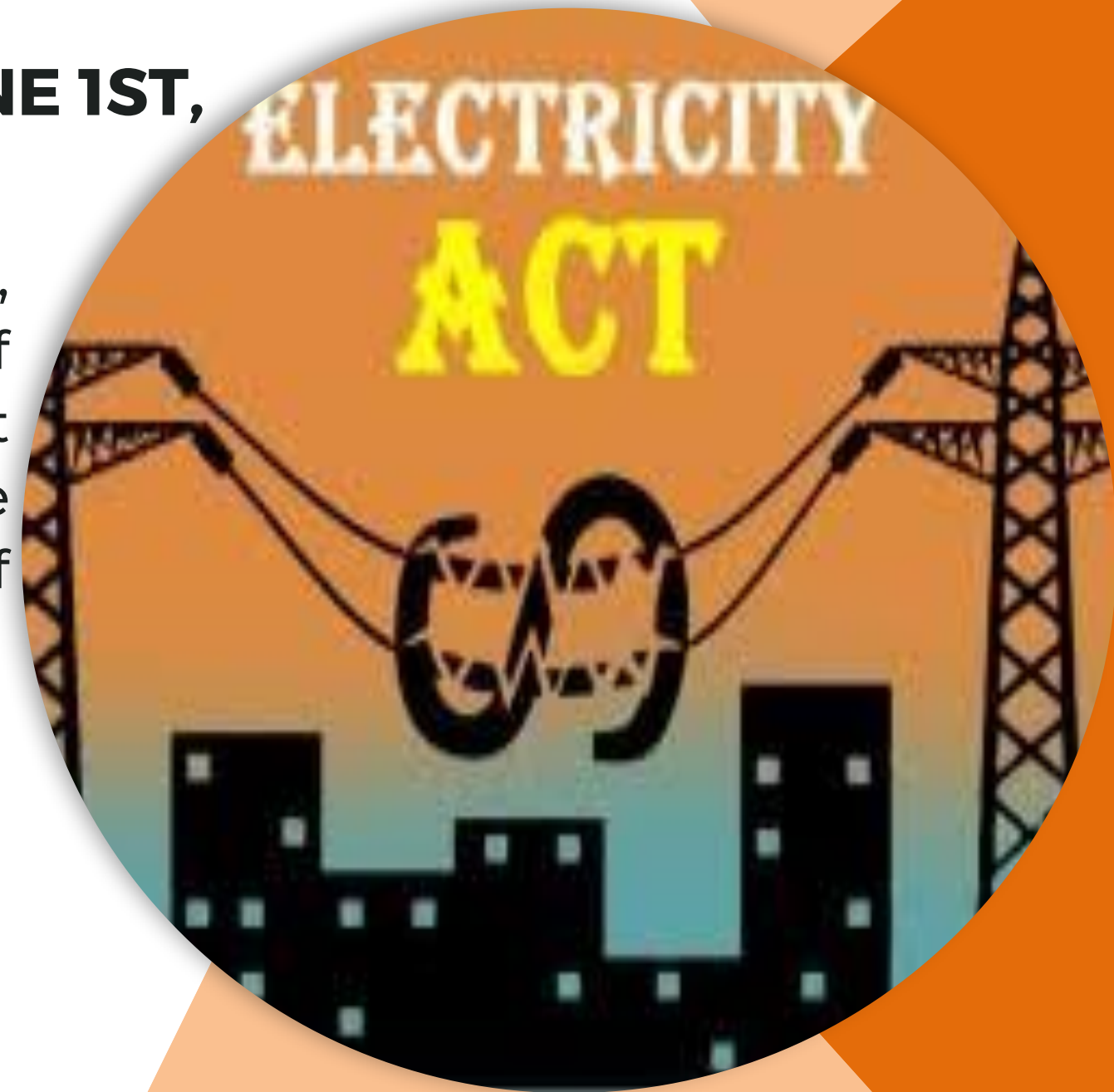

MINISTRY OF POWER- ENFORCEMENT OF JAN VISHWAS AMENDMENTS UNDER ELECTRICITY ACT, 2003 FROM JUNE 1ST, 2026.

Ministry of Power, vide Notification No. S.O. 2552(E) dated 18.05.2026, notifies that the 1st June, 2026 as the date on which the provisions of the Jan Vishwas (Amendment of Provisions) Act, 2026, in so far as it relates to serial number 58 and the entries relating thereto in the Schedule to the said Act, relating to the Electricity Act, 2003 (36 of 2003) shall come into force.

MINISTRY OF POWER- ENFORCEMENT OF JAN VISHWAS AMENDMENTS UNDER DAMODAR VALLEY CORPORATION ACT,1948 FROM JUNE 1ST, 2026

The Ministry of Power, vide Notification No. S.O. 2551(E) dated 18.05.2026, has notified 1st June, 2026 as the effective date for the enforcement of provisions of the Jan Vishwas (Amendment of Provisions) Act, 2026, insofar as they relate to serial number 11 and corresponding entries in the Schedule concerning the Damodar Valley Corporation Act, 1948. Accordingly, the relevant amendments under the Jan Vishwas Act pertaining to the Damodar Valley Corporation Act shall come into force from the said date.

COMMISSION FOR AIR QUALITY MANAGEMENT- CAQM INTENSIFIES AIR POLLUTION CONTROL MEASURES ACROSS DELHI-NCR

The Commission for Air Quality Management (CAQM), through Press Release dated 19.05.2026, has undertaken significant measures to strengthen air pollution control in Delhi-NCR. CAQM invoked Stage-I of the Graded Response Action Plan (GRAP) across NCR following deterioration of Delhi's AQI to the 'Poor' category, mandating dust mitigation, stricter vehicular emission checks, waste management, industrial compliance, and public awareness measures. Further, during its 28th Full Commission meeting, CAQM approved draft directions for complete elimination of paddy stubble burning, phased registration of only electric three-wheelers in NCR, and mandatory Pollution Under Control Certificates for fuel dispensing from October 2026. Additionally, the Enforcement Task Force reviewed compliance actions, reporting inspections of industrial units, construction sites, and DG sets, with closure directions, penalties, and intensified monitoring aimed at ensuring stricter adherence to environmental norms across the region.

FSSAI- THE FOOD SAFETY AND STANDARDS (CONTAMINANTS, TOXINS AND RESIDUES) AMENDMENT REGULATIONS, 2026

The Food Safety and Standards Authority of India vide Notification F. No. 01/SP-02/S&S/NotificationContaminants/2021-22 dated 19.05.2026, notifies the Food Safety and Standards (Contaminants, Toxins and Residues) Amendment Regulations, 2026, effective from 1st December 2026. The amendment updates permissible limits and testing requirements for contaminants such as lead, arsenic, cadmium, aflatoxins, saffrole, trimethoprim, and oxolinic acid in various food products including pulses, edible oils, oilseeds, seafood, and fish oils. The notification also introduces revised compliance and testing procedures to strengthen food safety standards and consumer protection in India.

CENTRAL ELECTRICITY REGULATORY COMMISSION- THE DRAFT CENTRAL ELECTRICITY REGULATORY COMMISSION (CONNECTIVITY AND GENERAL NETWORK ACCESS TO THE INTER STATE TRANSMISSION SYSTEM) (FOURTH AMENDMENT) REGULATIONS, 2026

The Central Electricity Regulatory Commission vide Notification No. L-1/261/2021/CERC dated 20.05.2026, has notified the Draft Fourth Amendment Regulations, 2026 to amend the Connectivity and General Network Access (GNA) Regulations for the inter-State transmission system. The draft introduces new provisions related to connectivity withdrawal, Land Bank Guarantees (Land BG), Energy Storage Systems (ESS), renewable energy projects, source change permissions, transfer of GNA, and timelines for financial closure and land compliance. It also simplifies connectivity processes, clarifies rules for multi-location renewable projects, and strengthens operational flexibility for generators, transmission licensees, and drawee entities connected to the ISTS network.

FSSAI- THE DRAFT FOOD SAFETY AND STANDARDS (FOOD PRODUCTS STANDARDS AND FOOD ADDITIVES) AMENDMENT REGULATIONS, 2026

The Food Safety and Standards Authority of India vide Notification F No. SS-TOFA(NOTI)/4/2025-Standard-FSSAI dated 25.05.2026, notifies the Draft Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2026. It amends Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011 by inserting Sub-Regulation 2.2.10- Minor Seed Oils (Chilli seed oil, Muskmelon seed oil, Okra seed oil and Tomato seed oil) after sub-Regulation 2.2.9 in Regulation 2.2, sub-regulation 2.3.66- Edible Seeds after 2.3.65 in regulation 2.3.

The Food Safety and Standards Authority of India vide Notification F No. RCD-02002/1/2025-Regulatory-FSSAI. dated 25.05.2026, notifies the Draft Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2026. In the Food Safety and Standards (Food Safety Auditing) Regulations, 2018, in regulation 3, in sub-regulation (1), in clause (c)- (1) sub clause (i), (2) sub clause (ii), (3) sub clause (v) shall be substituted with new provision.

MINISTRY OF PETROLEUM AND NATURAL GAS- THE LIQUEFIED PETROLEUM GAS (REGULATION OF SUPPLY AND DISTRIBUTION) AMENDMENT ORDER, 2026

The Ministry of Petroleum and Natural Gas vide Notification No. G.S.R. 406(E) dated 25.05.2026, notifies the Liquefied Petroleum Gas (Regulation of Supply and Distribution) Amendment Order, 2026. In the Liquefied Petroleum Gas (Regulation of Supply and Distribution) Order, 2000, in clause 3, for sub-clause (5), sub-clause shall be substituted with new provision.

MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE- DRAFT AMENDMENT TO CRZ NOTIFICATION FOR STORAGE OF PETROLEUM PRODUCTS IN COASTAL AREAS

The Ministry of Environment, Forest and Climate Change, vide Draft Notification No. G.S.R. 410(E) dated 26.05.2026, has proposed amendments to the Coastal Regulation Zone (CRZ) Notification, 2019 to permit the receipt and storage of Linear Alkyl Benzene (LAB), N-Paraffin, and Carbon Black Feedstock (CBFS) in CRZ areas, excluding CRZ-IA areas. The proposal follows recommendations from the Expert Appraisal Committee and the National Coastal Zone Management Authority, considering the comparatively lower hazardous nature of these chemicals. The draft amendment seeks to include these substances in Annexure-II of the CRZ Notification, 2019, and objections or suggestions from stakeholders may be submitted within 60 days from the date of publication of the notification.

MINISTRY OF CHEMICALS AND FERTILIZER- NPPA REVISES CEILING PRICE OF BENZATHINE BENZYL PENICILLIN

The Ministry of Chemicals and Fertilizers, Department of Pharmaceuticals, through the National Pharmaceutical Pricing Authority (NPPA), vide Order No. S.O. 2681(E) dated 27.05.2026, has revised the ceiling price of the scheduled formulation Benzathine Benzylpenicillin Powder for Injection (6 lakh units). Taking into account the review order and the Wholesale Price Index (WPI) impact of 0.64956% for 2026, the ceiling price has been increased from ₹11.97 to ₹13.42 per vial (exclusive of GST). The order supersedes the earlier price notification and requires manufacturers to align their prices with the revised ceiling price in accordance with the provisions of the Drugs (Prices Control) Order, 2013.

MINISTRY OF CHEMICALS AND FERTILIZERS- NPPA FIXES RETAIL PRICES FOR 30 NEW DRUG FORMULATIONS

The Ministry of Chemicals and Fertilizers, Department of Pharmaceuticals, through the National Pharmaceutical Pricing Authority (NPPA), vide Order No. S.O. 2680(E) dated 27.05.2026, has fixed the retail prices of 30 new drug formulations under the provisions of the Drugs (Prices Control) Order, 2013. The notified formulations include combinations used for the treatment of cardiovascular diseases, diabetes, infections, pain management, gastrointestinal disorders, and nutritional deficiencies. Manufacturers and marketing companies are required to comply with the approved retail prices, issue revised price lists, and adhere to all applicable provisions of the DPCO, 2013, failing which they may be liable for recovery of overcharged amounts along with interest.

COMMISSION FOR AIR QUALITY MANAGEMENT- CAQM CONDUCTS SPECIAL INSPECTION DRIVE IN GHAZIABAD, ORDERS STRONGER DUST CONTROL MEASURES

Ministry of Environment, Forest and Climate Change through Commission for Air Quality Management, issued Press Release dated 27.05.2026 informed that a special inspection drive was conducted in Ghaziabad on 26.05.2026, to assess road dust levels and the effectiveness of road cleaning operations. During the inspection, 24 instances of excessive road dust and accumulation of construction and demolition (C&D) waste were identified across various locations. In response, CAQM directed the concerned authorities to strengthen dust mitigation measures through deep cleaning, mechanized road sweeping, water sprinkling, and scientific disposal of C&D waste. The Commission also emphasized stricter monitoring, accountability of responsible officers, and continued inspections under 'Operation Clean Air' to curb air pollution across the Delhi-NCR region.

MINISTRY OF ROAD TRANSPORTATION AND HIGHWAYS- THE CENTRAL MOTOR VEHICLES (EIGHTH AMENDMENT) RULES, 2026

Ministry of Road Transportation and Highways vide Notification No. G.S.R. 417(E) dated 29.05.2026, has amended the Central Motor Vehicles Rules, 1989 with immediate effect. The amendment replaces existing provisions relating to hydrogen-powered vehicles and prescribes updated safety and procedural requirements for type approval of vehicles powered by liquid or compressed gaseous hydrogen, including internal combustion engine vehicles, fuel cell vehicles, and construction equipment vehicles. The revised framework aligns vehicle approvals with the latest Automotive Industry Standards (AIS) and hydrogen fuel specifications, thereby facilitating the safe adoption and regulation of hydrogen-based mobility technologies in India.

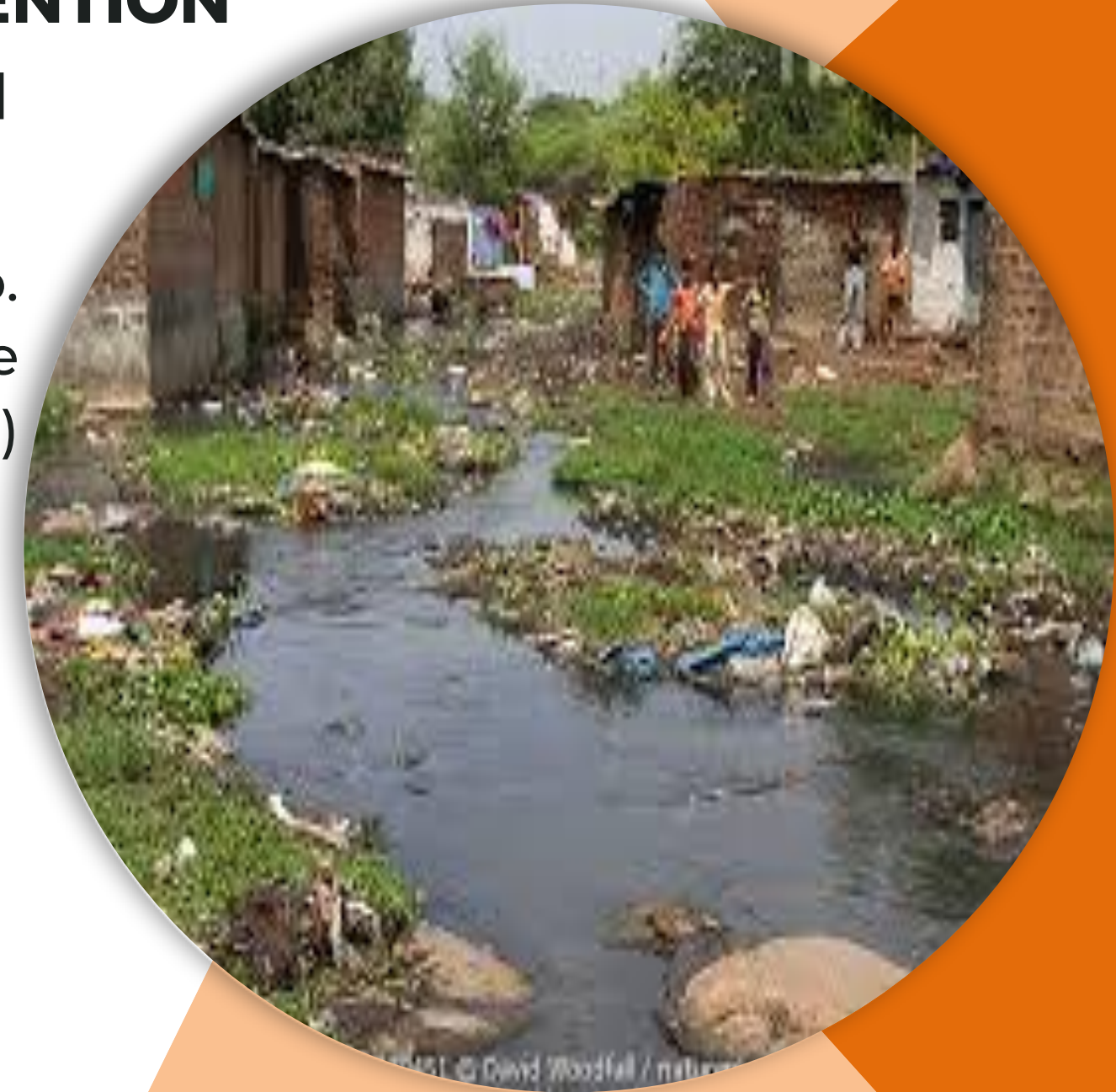

MADHYA PRADESH- STATE ADOPTION OF WATER (PREVENTION AND CONTROL OF POLLUTION) AMENDMENT ACT, 2024 IN MADHYA PRADESH

ANDHRA PRADESH- AMENDMENTS TO THE ANDHRA PRADESH MUNICIPALITIES (REGULATION OF RECEIPTS AND EXPENDITURE) RULES, 1968

The Government of Andhra Pradesh, vide G.O.Ms. No. 92 dated 01.05.2026, has amended the Andhra Pradesh Municipalities (Regulation of Receipts and Expenditure) Rules, 1968, to revise the framework for fixation and renewal of lease rents for municipal immovable properties. The amendments prescribe a revised methodology for determining upset prices based on market value or prevailing rents, mandate a 7% annual rent escalation during lease periods, and provide differentiated pricing for upper-floor commercial spaces. Further, Municipal Councils/Corporations may renew leases for up to three years without auction, and up to twenty-five years with prior Government approval, subject to annual rent revisions.

GUJARAT - STAKEHOLDERS UNDER ENVIRONMENT PROTECTION (END-OF-LIFE VEHICLES) RULES, 2025 ARE REQUIRED TO REGISTER ON THE CPCB EPR PORTAL

Gujarat Pollution Control Board vide Public Notice dated 08.05.2026, issued that the Environment Protection (End-of-Life Vehicles) Rules, 2025 applies to Producers, Registered Owners of Vehicles, Bulk Consumers, Registered Vehicle Scrapping Facilities (RVSFs), Collection Centres, and Automated Testing Stations. As per Environment Protection (End-of-Life Vehicles) Rules, 2025, all stakeholders, namely Producer, Bulk Consumers and Registered Vehicle Scrapping Facilities (RVSFs) are required to register on the CPCB EPR Portal and ensure compliance. RVSFs carrying out operation without valid consent to operate are hereby directed to cease operations immediately and apply online for CTE and CCA through the GPCB XGN Portal under the prevailing consent mechanism. Any non-compliance shall attract action under the Environment (Protection) Act, 1986.

CHANDIGARH- THE CHANDIGARH LEGAL METROLOGY (ENFORCEMENT) (AMENDMENT) RULES, 2026

Chandigarh Administration, Department of Food & Supplies and Consumer Affairs & Legal Metrology, vide Notification No. 638714-FS&CA-2026/3916 dated 08.05.2026, notifies the Chandigarh Legal Metrology (Enforcement) (Amendment) Rules, 2026. The draft proposes issuance of licenses to manufacturers and dealers of weights and measures, as well as registration of packers/importers, on a self-declaration basis without prior physical inspection. It also introduces auto-renewal of licenses subject to fee payment and submission of periodic returns. Additionally, a new Schedule XII is proposed, classifying weights and measuring instruments into high, medium, and low-risk categories to streamline regulatory oversight.

DELHI- DRAFT DELHI LEGAL METROLOGY (ENFORCEMENT) AMENDMENT RULES, 2026.

Government of the National Capital Territory of Delhi, the Weights and Measures Department, vide Notification No. F. 12(2)/W&M/Enforcement/2026/261-69 dated 11.05.2026, has issued the draft Delhi Legal Metrology (Enforcement) Amendment Rules, 2026, proposing significant amendments to the Delhi Legal Metrology (Enforcement) Rules, 2011. The draft rules introduce a self-declaration-based licensing mechanism for manufacturers, repairers, and dealers of weights and measures without prior inspection, provide for perpetual validity of licences unless suspended or cancelled, and remove provisions relating to licence renewal. The amendments also revise application forms, licensing formats, fee schedules, security deposits, and registers to be maintained under the Rules.

HIMACHAL PRADESH- DRAFT HIMACHAL PRADESH ELECTRICITY REGULATORY COMMISSION (PROMOTION OF GENERATION FROM THE RENEWABLE ENERGY SOURCES AND TERMS AND CONDITIONS FOR TARIFF DETERMINATION) (EIGHTH AMENDMENT) REGULATIONS, 2026

The Himachal Pradesh Electricity Regulatory Commission, vide Notification No. HPERC/428 dated 12.05.2026, has issued draft amendments to the Himachal Pradesh Electricity Regulatory Commission (Promotion of Generation from the Renewable Energy Sources and Terms and Conditions for Tariff Determination) Regulations, 2017 to align certain provisions with the Central Electricity Regulatory Commission (Terms and Conditions for Tariff Determination from Renewable Energy Sources) Regulations, 2024. The proposed amendments seek to introduce definitions for “Biomass” and “Biomass Gasification” and revise the definition of “Useful Life” for various renewable energy projects, including wind, biomass, solar, small hydro, hybrid and renewable energy with storage projects. KARNATAKA- THE KARNATAKA MOTOR VEHICLES (AMENDMENT) RULES, 2026

Government of Karnataka vide Notification No. TD 147 TDO 2025 dated 12.05.2026, notifies the Karnataka Motor Vehicles (Amendment) Rules, 2026, introducing comprehensive provisions for non-motorised transport (NMT), pedestrian infrastructure, and road safety standards under the Karnataka Motor Vehicles Rules, 1989. The amendment inserts new chapters prescribing design, construction, maintenance, monitoring and enforcement standards for footpaths, cycle tracks, pedestrian crossings, school zones, bus stops and NMT-only zones, while imposing responsibilities on road-owning agencies and motorists to ensure pedestrian and cyclist safety. The Rules further mandate road safety audits, prescribe technical engineering standards for roads, establish grievance redressal and monitoring mechanisms, and provide penalties for non-compliance causing injury or death due to deficient road infrastructure or violations by motorists.

GUJARAT- IMPLEMENTATION AND COMPLIANCE OF SOLID WASTE MANAGEMENT RULES, 2026

Gujarat Pollution Control Board issued Public Notice on 13.05.2026, regarding Implementation and Compliance of Solid Waste Management Rules, 2026. It specifies that every individual and institution generating waste is obligated to fulfil the key duties and responsibilities. It specifies the Four-Stream Segregation of Solid Waste at the source of generation, Responsibilities of New Bulk Waste Generators (BWGs), Use of RDF (Refuse Derived Fuel) by Industries, Strict Penalties and Environmental Compensation, Online Monitoring, Stakeholders Covered Under the Solid Waste Management Rules-2026. All stakeholders, including (BWGs), local bodies, municipalities, MRFs, recycling facilities, etc. are required to mandatorily register on the CPCB's EPR Portal and ensure compliance with the Solid Waste Management Rules-2026. All stakeholders shall be held responsible for compliance, and violations shall face legal consequences under the Environment Protection Act, 1986.

DADRA AND NAGAR HAVELI AND DAMAN AND DIU- THE DADRA AND NAGAR HAVELI AND DAMAN AND DIU REGISTRATION OF SOCIETIES REGULATION, 2026

Ministry Of Law and Justice vide Notification No. 17 dated 15.05.2026, notifies the Dadra and Nagar Haveli and Daman and Diu Registration of Societies Regulation, 2026 to streamline the registration, governance, functioning, audit, amalgamation, dissolution and regulatory oversight of societies in the Union Territory. The Regulation prescribes detailed provisions relating to registration procedures, eligibility and membership, governance through General Body and Governing Body, maintenance of accounts and audit, filing of annual returns, and powers of Registrars to conduct inquiries, supersede governing bodies, and cancel registrations in cases of non-compliance or unlawful activities. It also introduces provisions for e-governance, penalties for contraventions, and mechanisms for dissolution and disposal of assets of societies.

LAKSHADWEEP- THE LAKSHADWEEP FIRE AND EMERGENCY SERVICE REGULATION, 2026

Ministry Of Law and Justice vide Notification No. 16 dated 15.05.2026, notifies the Lakshadweep Fire and Emergency Service Regulation, 2026 to establish and regulate fire and emergency services in the Union Territory of Lakshadweep and strengthen fire prevention and life safety measures. The Regulation provides for the constitution and administration of the fire and emergency service, establishment of fire stations, appointment of Fire Safety Officers, mandatory fire safety compliance for specified buildings and premises, issuance of Fire Safety Certificates, inspection powers, and emergency response mechanisms. It also introduces provisions relating to fire tax, penalties for non-compliance, firefighting operations, emergency preparedness, and powers of authorities to disconnect utilities or seal unsafe buildings to ensure public safety and effective fire risk management.

ANDAMAN AND NICOBAR ISLANDS- THE ANDAMAN AND NICOBAR ISLANDS FIRE AND EMERGENCY SERVICE REGULATION, 2026

The Ministry of Law and Justice, vide Notification No. 19 dated 25.05.2026, has promulgated the Andaman and Nicobar Islands Fire and Emergency Service Regulation, 2026 to establish and strengthen the Fire and Emergency Service framework in the Union Territory of Andaman and Nicobar Islands. The Regulation provides for fire prevention and life safety measures in buildings and premises, mandates fire safety certificates for specified buildings, appointment of Fire Safety Officers, inspection and enforcement powers, emergency response mechanisms, levy of fire tax, and penalties for non-compliance. It also lays down provisions relating to firefighting operations, training, appeals, and coordination for disaster and emergency management.

DELHI- THE DELHI FIRE SERVICE (AMENDMENT) RULES, 2025.

The Government of the National Capital Territory of Delhi, vide Notification No. DFS/HQ/Misc./2025/01(E-259159)/237 dated 26.05.2026, has notified the Delhi Fire Service (Amendment) Rules, 2025 to amend the Delhi Fire Service Rules, 2010. The amendment introduces provisions for empanelment of third-party Fire Safety Auditors for issuance of fire safety certificates, annual online declarations for maintaining fire safety compliance, and deployment of an Automated Continuous Monitoring System (ACMS) for specified occupancies. It also revises fire risk occupancy categories, updates fire safety certification procedures, enables online payment mechanisms, and restructures fire service zones and divisions to strengthen fire prevention and safety compliance in Delhi.
