PETROLEUM AND EXPLOSIVE SAFETY ORGANISATION- CIRCULAR ON HYDROGEN GAS CYLINDERS CASCADE MOUNTED ON THE CHASSIS OF A VEHICLE FOR TRANSPORTATION OF HYDROGEN BY ROAD

Petroleum and Explosive Safety Organisation vide Circular No. C.VIII(3)125/CIR/GCR dated 02.02.2026 states that as per Rule 20 of the Gas Cylinder Rules, 2016, Hydrogen Gas Cylinders Cascade mounted on the chassis of a vehicle can be used for transportation of Hydrogen gas after complying with provision of Schedule-VI of the said Rules. This transportation does not require any licence under the said Rules 2016. However, the cylinders shall be PESO approved and License in Form E&F is essential for filling and storage of compressed gas in these cascades. And License in Form D is also essential for import of such gas cylinders.

In the New Drugs and Clinical Trials Rules, 2019, the sub-rule (3) of rule 17 shall be omitted and the sub-rule (4) of rule 17 shall be substituted, namely: — “On receipt of application in Form CT-01 under sub-rule (1), the authority designated under sub-rule (1) shall scrutinise the documents and information furnished with the application, and if satisfied that the requirements of these rules have been complied with, grant final registration to Ethics Committee in Form CT-03; or if not satisfied, reject the application, for reasons to be recorded in writing”.

MINISTRY OF POWER- AUTHORIZATION FOR OVERHEAD TRANSMISSION LINE FOR INTEGRATION OF BIJAPUR REZ IN KARNATAKA

The Ministry of Power vide Order S.O. 485(E) dated 03.02.2026, issued under section 164 of the Electricity Act, 2003, has authorized M/s Bijapur REZ Transmission Limited to exercise the powers of a telegraph authority for laying an overhead transmission line under the transmission scheme for integration of Bijapur REZ in Karnataka. Ministry of Commerce and Industry vide Notification No. G.S.R. 104(E) dated 04.02.2026 notifies draft rules known as the Ammonium Nitrate (Amendment) Rules, 2026. These rules amend Ammonium Nitrate Rules, 2012, in rule 21- (A) in sub-rule (1), after word "Consignors", the words "or Consignee" shall be inserted. (B) in sub-rule (1), after words "holding valid licence in Form P-4" the following clauses shall be inserted, namely: - "subject to (a) if transport vehicle is provided by the consignee, the Ammonium Nitrate should be transported on the strength of transport licence of consignee. (b) if transport vehicle is provided by the consignor, the Ammonium Nitrate should be transported on the strength of transport licence of consignor." (C) in sub-rule (6) after word "Consignor" and before the words "shall ensure delivery", the words "or Consignee", shall be Inserted. In the said rules, in rule 38, in sub-rule (e) after word "office-bearers", the words "or occupier" shall be inserted.

MINISTRY OF ROAD TRANSPORTATION AND HIGHWAYS-

VEHICLE SCRAPPAGE POLICY AND ROAD SAFETY INITIATIVES

The Ministry of Road Transport and Highways, through a Press Release issued by the Press Information Bureau on 04.02.2026, informed that as of 30.01.2026, a total of 129 Registered Vehicle Scrapping Facilities are operational across 21 States and Union Territories, and over 4.30 lakh vehicles have been scrapped under the Vehicle Scrappage Policy. The Ministry also highlighted the Special Assistance to States for Capital Investment (SASCI) 2025–26, under which incentives amounting to ₹2,000 crore have been extended for scrapping of old vehicles and establishment of Automated Testing Stations. Further, the Press Release outlined key road safety initiatives, including implementation of the Cashless Treatment of Road Accident Victims Scheme, 2025, measures for rectification of accident black spots, mandatory road safety audits, electronic enforcement of traffic rules, and enhanced incentives for Good Samaritans, aimed at improving road safety and reducing fatalities nationwide.

PETROLEUM AND EXPLOSIVES SAFETY ORGANISATION- THIRD PARTY USE OF STORAGE SHED FOR NON-BULK STORAGE OF PETROLEUM PRODUCTS LICENSED UNDER PETROLEUM RULES, 2002

Government of India, Petroleum and Explosives Safety Organisation vide Circular No. VIII(3)125/Circular/Petroleum dated 05.02.2026 states that the License for storage of petroleum under Rule 141 of the Petroleum Rules, 2002, is issued in the name of applicant, who has registered the lease deed/sale deed of his land. The Licensee may allow use of storage spaces by 3rd party logistics company and allow sharing of storage space subject to compliance of provisions of Petroleum Rules, 2002 and conditions of License. And responsibility for compliance lies with licensee and the storage quantity shall not exceed the licensed capacity.

MINISTRY OF ROAD TRANSPORT AND HIGHWAYS- ADVISORY TO STATES ON COMPLIANCE WITH BUS SAFETY STANDARDS FOLLOWING SLEEPER BUS FIRE INCIDENTS

The Ministry of Road Transport & Highways on 11.02.2026 has issued an advisory to all States and Union Territories to ensure strict compliance with AIS:052 and AIS:119 at the time of vehicle registration and fitness inspection under Rule 62 of the Central Motor Vehicles Rules, 1989, following recent fatal sleeper bus fire incidents on the Jaisalmer-Jodhpur and Kurnool-Bengaluru routes. The Government observed multiple safety violations in the Jaisalmer incident, including excessive bus length, non-compliant emergency exits, inadequate roof hatches, obstruction to emergency doors, absence of a compliant Fire Detection & Suppression System, and improper structural modifications that should have been identified during certification. In the Kurnool-Bengaluru case, discrepancies were noted in the registration certificate indicating only seating capacity. As informed by Union Minister Nitin Jairam Gadkari in a written reply to the Rajya Sabha, there are 49,616 registered sleeper coaches in the country as of 6 February 2026, and 886 bus body builders have been accredited to date. THE COMMISSION FOR AIR QUALITY MANAGEMENT - CAQM ISSUES TECHNICAL AND OPERATIONAL NORMS FOR MECHANIZED ROAD SWEEPING TO CURB ROAD DUST IN NCR

The Commission for Air Quality Management (CAQM), under the Ministry of Environment, Forest and Climate Change, has issued a detailed circular dated 11.02.2026, prescribing technical and operational norms for deployment and utilization of Mechanized Road Sweeping Machines (MRSMs) across the National Capital Region (NCR) to mitigate road dust and reduce PM10 and PM2.5 levels. The norms categorize MRSMs into large, medium, and small variants based on road Right of Way (RoW), mandate CNG/electric-operated machines with integrated water spraying and dust filtration systems and prescribe minimum operational coverage standards per shift. The circular also directs agencies to adopt structured fleet planning, ensure alternate-day sweeping, deploy handheld vacuum cleaners for footpaths, and follow scientific disposal of collected dust. The initiative aims to standardize road sweeping practices across NCR for measurable and sustained abatement of dust pollution. [View Notification](#)

COMMISSION FOR AIR QUALITY MANAGEMENT- REVOCATION OF STAGE-II GRAP MEASURES IN DELHI-NCR AMID IMPROVED AIR QUALITY

The Commission for Air Quality Management (CAQM), vide Order No. 120017/27/GRAP/2021/CAQM/560DT dated 18.02.2026, has revoked actions under Stage-II ('Very Poor' Air Quality) of the extant Graded Response Action Plan (GRAP) with immediate effect, following improvement in Delhi's Air Quality Index (AQI), which was recorded at 214 on 18.02.2026. Based on favourable meteorological conditions and forecast by IMD/IITM indicating AQI likely to remain in 'Poor/Moderate' category in the coming days, the Sub-Committee on GRAP decided to withdraw Stage-II measures. However, Stage-I actions under GRAP will continue to remain in force across the NCR, with directions to all concerned agencies to strictly implement and intensify measures to prevent further deterioration of air quality.

IMPROVES

Ministry of Environment, Forest and Climate Change via PIB on 18.02.2026 states that the Sub-Committee on Graded Response Action Plan (GRAP) of the Commission for Air Quality Management (CAQM), has revoked all actions under Stage-II of GRAP across the Delhi-NCR region with immediate effect, in view of sustained improvement in air quality. Stage-II had been invoked on 19.10.2025 following a rising AQI trend. As per the AQI Bulletin of the Central Pollution Control Board, Delhi's daily average AQI improved. Considering favourable meteorological conditions and forecasts by IMD/IITM indicating AQI likely to remain in the 'Poor' to 'Moderate' category, the Sub-Committee decided to lift Stage-II restrictions. However, all actions under Stage-I of GRAP shall continue to remain in force and implementing agencies have been directed to maintain strict vigilance to prevent deterioration in air quality.

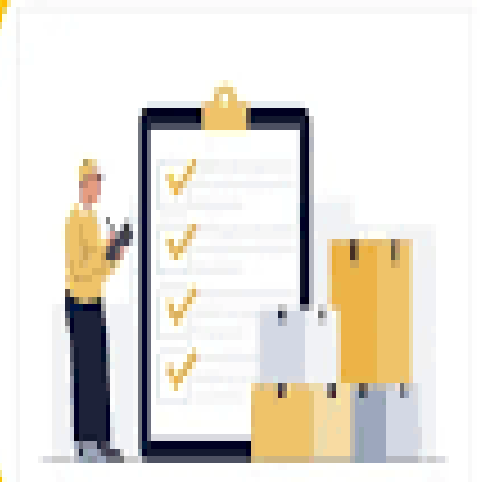

Considering consumer representations and requests from DISCOMs, the Commission has kept in abeyance its earlier directions issued in the Retail Supply Tariff Order for FY 2019–20 on unblocking of leading kVARh for LT services. APERC has further directed DISCOMs to withdraw excess bills already paid due to leading reactive energy after smart meter installation and to adjust the excess amounts in subsequent bills, in order to safeguard consumer interests while supporting the smart metering programme.

RAJASTHAN- RSPCB ADOPTS REVISED CPCB SECTOR CATEGORIZATION AND ISSUES FRESH DELEGATION OF POWERS FOR CONSENT AND AUTHORIZATIONS

The Rajasthan State Pollution Control Board (RSPCB), vide Office Order No. F-12 (PSC-65)/RSPCB/3226-3237 dated 16.02.2026, states that Office Orders dated 21.01.2026 and 30.01.2026, has adopted the revised sector categorization framework issued by the Central Pollution Control Board (CPCB) for classification of industries under Red, Orange, Green, White and Blue categories. The Board has also notified a revised delegation of powers for grant, refusal and revocation of Consent to Establish/Operate under the Water Act, 1974 and Air Act, 1981, and for grant of authorizations under the Hazardous and Other Wastes Rules, 2016, Bio-Medical Waste Management Rules, 2016, and Plastic Waste Management Rules, 2016. It has been clarified that applications received on or after 01.02.2026 shall be processed as per the revised categorization and delegation framework, while applications received prior to 01.02.2026 shall be dealt with under the earlier orders.

RAJASTHAN- RSPCB RECOGNIZES REFUSE DERIVED FUEL (RDF) AS APPROVED FUEL SUBJECT TO TECHNICAL AND REGULATORY CONDITIONS

The Rajasthan State Pollution Control Board (RSPCB), vide Office Order No. F.14/(5)Admn/RSPCB/Plg dated 16.02.2026, has partially modified its earlier order dated 22.11.2019 to include Refuse Derived Fuel (RDF) as an “Approved Fuel” under Serial No. 16, subject to specified technical and regulatory conditions. The order mandates that RDF may be used only in boilers above 8 TPH capacity, which are multi-fuel fired and designed to achieve a minimum temperature of 950°C, along with installation or retrofitting of suitable pollution control devices to meet prescribed emission standards. It further requires compliance with the Solid Waste Management Rules, 2016, and clarifies that any specific directions issued by the Government or the Commission for Air Quality Management, as well as CEPI guidelines, shall prevail over this order.

DELHI- CAQM ISSUES DIRECTION ON DUST MITIGATION AND MANDATORY DEMOLITION WASTE MANAGEMENT IN DELHI-NCR

The Commission for Air Quality Management (CAQM) in NCR and Adjoining Areas, vide F. No. A-110018/01/2021-CAQM-1563 DT dated 20.02.2026 issued under Section 12 of the CAQM Act, 2021, and has directed stricter measures for mitigation of dust from construction and demolition (C&D) activities and scientific management of demolition waste across Delhi-NCR. The Direction mandates Municipal Corporations and Development Authorities to establish designated C&D waste collection points within a 5 km × 5 km grid, require declaration and prior deposition of demolition waste for projects of 200 sq. meters or more, and ensure verification before issuance of Completion/Occupation Certificates. It also calls for GPS tracking of C&D waste transportation, geo-tagging of facilities, and creation of an integrated web portal for monitoring. The Directions shall come into force from 01.04.2026, and non-compliance may attract penal action under Section 14 of the Act. [**View Notification**](#)

DELHI- CAQM DIRECTS REVISED PM EMISSION STANDARD OF 50 MG/NM³ FOR INDUSTRIES ACROSS DELHI-NCR

The Commission for Air Quality Management (CAQM) in NCR and Adjoining Areas, vide F. No. A-110018/01/2021-CAQM/1564 dated 20.02.2026 issued under Section 12 of the CAQM Act, 2021, has stipulated a revised maximum permissible particulate matter (PM) emission standard of 50 mg/Nm³ for 17 categories of highly polluting industries, Red category (medium and large) industries, food & food processing and textile units with boilers/thermic fluid heaters, and metal industries with furnaces operating across Delhi-NCR. The revised standard, based on recommendations of the Central Pollution Control Board and a study conducted by Indian Institute of Technology Kanpur, shall be applicable from 01.08.2026 for medium and large industries and from 01.10.2026 for remaining industries. The direction overrides earlier norms of 80 mg/Nm³ prescribed under previous CAQM directions and mandates installation/upgradation of Air Pollution Control Devices to ensure compliance.
